<b>1</b>	<p>Welcome—Hon. Tom Foster, chair</p> <ul style="list-style-type: none"> <li>The committee discussed the Kansas Payment Center tour</li> </ul>
<b>2</b>	<p>Review and Approve Minutes from the August 31, 2018 meeting</p> <ul style="list-style-type: none"> <li>C. Harris moved to adopt the minutes</li> <li>Judge C. Alvey seconded the motion</li> <li>The committee approved the August 31, 2018 meeting minutes</li> </ul>
<b>3</b>	<p>Tax subcommittee—Doni Mooberry</p> <ul style="list-style-type: none"> <li>D. Mooberry stated the IRS issued a draft of Form 8332; the form is still in the comment phase</li> <li>Form 8332 will still need to be filed with returns</li> <li>The committee discussed what to do if a parent who is not to claim the children files first; J. Alvey asked whether the IRS corrects the return.</li> <li>S. Loveland stated the IRS returns the taxes to the parent who tries to claim the child second; the rule is who files first is able to claim the child; the remedy is to file a contempt action in the domestic case</li> <li>C. Harris discussed the tax table update; a copy was distributed to committee members</li> </ul>
<b>4</b>	<p>Shared residency subcommittee—Michelle Slinkard</p> <ul style="list-style-type: none"> <li>The subcommittee has no new updates. The group is waiting on the economist report to proceed.</li> </ul>
<b>5</b>	<p>Unreimbursed medical expenses—Sherri Loveland</p> <ul style="list-style-type: none"> <li>Proposed language was distributed to the committee</li> <li>S. Loveland discussed the purpose/need for the language</li> <li>C. Harris requested sanction language be added for failure to pay uncovered health insurance costs including an option for the court to require the non-payor to pay 100%</li> <li>C. Harris asked the committee to consider when the 30 day notice period should start—at the time the explanation of benefits (EOB) is received, at the time the bill is received, or when both are received?</li> <li>The committee discussed several scenarios and how to handle each with the proposed language</li> <li>S. Loveland and C. Harris will refine the language based on discussions and present revised language at the next meeting</li> </ul>
<b>6</b>	<p>Other items for discussion</p> <ul style="list-style-type: none"> <li>Requesting publication of cases: at the last meeting, it was decided that Judge T. Foster would file a motion to request publication of cases; the appellate clerk's office doesn't believe it is appropriate for Judge Foster to enter an appearance and file the motion; C. Harris volunteered to file the motion</li> <li>Removing "nearly equal language" from the guidelines: C. Harris moved to remove the language from the guidelines based on prior committee discussions that it is confusing for practitioners and pro se litigants; S. Beezley seconded the motion; the committee approved removing the language.</li> </ul>
