

**KANSAS DEPT. OF WILDLIFE AND PARKS VIOLATIONS**  
**RECOMMENDED FINES**

IF THE AMOUNT OF THE FINE DOES NOT APPEAR ON THE BACK OF YOUR CITATION, YOU MAY BE REQUIRED TO APPEAR IN COURT BEFORE THE JUDGE. FINE AMOUNTS ARE ASSESSED AT THE DISCRETION OF THE JUDGE.

IF YOU HAVE MORE THAN ONE VIOLATION, YOU WILL NEED TO ADD THE AMOUNT OF THE FINE DUE FOR EACH VIOLATION. THERE ARE NO ADDITIONAL COURT COSTS FOR ADDITIONAL VIOLATIONS WRITTEN ON THE SAME TICKET.

IF YOU FAIL TO APPEAR OR PAY YOUR CITATION, A NOTICE IS SENT TO YOU. IF YOU STILL FAIL TO TAKE CARE OF YOUR CITATION, THE KS DEPARTMENT OF WILDLIFE & PARKS IS NOTIFIED TO SUSPEND ANY HUNTING, FISHING LICENSES, AND/OR STAMPS THAT YOU HAVE UNTIL THE CITATION HAS BEEN TAKEN CARE OF. THERE IS A \$50.00 REINSTATEMENT FEE FOR EACH CHARGE THAT IS FILED WITH THE COURT.
