**ORDER REGARDING RECORD ON APPEAL**

Because the Wyandotte County District Court may be unable to compile a record on appeal in this expedited case, Appellants have proposed an alternative method for compiling a substitute for the record on appeal. Appellees have not objected to that proposal. The court grants Appellants' Motion Regarding Record on Appeal with the following modifications.

After consultation with Appellees, Appellants must compile a Joint Appendix in lieu of a record on appeal. The Joint Appendix should include all currently available documents identified in Supreme Court Rule 3.02(c) (2022 Kan. S. Ct. R. at 20) and any additions that are part of the entire record under Supreme Court Rule 3.01 (2022 Kan. S. Ct. R. at 20). Appellants must note any unavailable documents required under Rule 3.02(c).

The Joint Appendix and any Supplemental Appendix should consist of file stamped or certified documents unless that is not feasible.

The court directs Appellants to compile the Joint Appendix in the following manner if feasible.

- Appellants must sequentially number each page in every volume of the record.
- Appellants should submit the documents required under Rule 3.02(c)(1)(A) and any additional documents that comply with Rule 3.01 in chronological order and in sequential volumes of no more than 250 pages.
- Appellants should submit each transcript in a separate volume. Appellants must clearly identify and label each transcript.
- Appellants should submit any clearly labeled exhibits in a separate volume.
- Appellants must prepare and submit a table of contents showing the volume number and page number of each document, transcript, or exhibit contained in the record.

Appellants must deliver the Joint Appendix in paper format to the Office of the Clerk of the Appellate Courts by 4 p.m. on May 2, 2022. Appellants must simultaneously serve the Joint Appendix on all parties.

Appellees must deliver any Supplemental Appendix in paper format to the Office of the Clerk of the Appellate Courts by 4 p.m. on May 9, 2022. Appellees must simultaneously serve any Supplemental Appendix on all parties. A Supplemental Appendix should comply with the formatting requirements set out above.

The parties must cite the Joint Appendix and any Supplemental Appendix in their briefs by volume and page number as required under Supreme Court rules.

A party may object to the inclusion of any materials in the Joint Appendix or any Supplemental Appendix by filing a motion with the court.
