## Order Amending Administrative Order No. 159 Re: Code of Civil Procedure for Limited Actions Forms

The 2000 Kansas Legislature enacted a new Code of Civil Procedure for Limited Actions effective January 1, 2001 (L. 2000, Ch. 161, *Session Laws of Kansas*).

Before the new code was enacted, the Kansas Judicial Council prepared forms reflecting the new code's provisions. Through Administrative Order No. 159, filed December 20, 2000, this court approved the use of these forms or substantially similar forms in districts courts on and after January 1, 2001, subject to future modification by the Kansas Legislature or by this court. Administrative Order No. 159 also provided for form updates or modifications as deemed necessary by the judicial administrator.

This order amends and supersedes Administrative Order No. 159 (attached). The necessary amendments are shown below through the underlining of words now added and the strikethrough of words now omitted.

Now, on this 20th day of December 2000 the matter comes before the court for action. After due consideration the use of said forms or substantially similar forms is approved in the district courts on and after January 1, 2001, subject, however, to future modification by the Kansas Legislature or by this court. These forms may be updated or minor modifications may be made as deemed necessary by the Judicial Administrator. The Kansas Judicial Council is not required to seek this court or the Office of Judicial Administration's approval to modify limited actions forms.
