

# Efiling a New Limited Actions Case or Transfer Pre-Judgment Limited Actions Chapter 61 Case to Civil Chapter 60 Case for Odyssey Courts

The District Courts of Kansas will be implementing a new statewide case management system over the next several months beginning August 5, 2019. The first counties to implement the Odyssey Case Management System are Clay, Riley, Dickinson, Geary, Marion, and Morris counties.

A change has been made to the Efiling system for the courts using the Odyssey Case Management System when filing a new Limited Actions case or Pre-Judgment Transfer Limited Actions Case to Civil case types. Filers will no longer enter the prayer amount when initiating these case types through the Efiling system. Instead filers will need to select the appropriate document type relating to the prayer amount. The appropriate filing fee will be calculated from the selection of the document type description containing the appropriate prayer amount.

If filing a new **Limited Actions** case, filers will have the option of selecting one the following document types:

PLE: Limited Action Petition Prayer Amount 0-500

PLE: Limited Action Petition Prayer Amount 500.01-5,000

PLE: Limited Action Petition Prayer Amount 5,000.01-25,000
